

Winter Wonderland Ice Rink & Ice Slide Release Form

Skating Rules

1. Obey skate guards at all times.
2. No skaters allowed during ice resurfacing.
3. Skates must be worn while on the ice.
4. No racing or speed skating.
5. No reckless skating or skating against traffic.
6. No eating or drinking on the ice.
7. No jumps or spins during public sessions.
8. No blocking of sideboards.
9. No chain skating.
10. No carrying people or articles on the ice.

Ice Slide Rules

1. Obey ice slide attendees at all times.
2. Follow all posted and verbal rules.
3. Must stay seated on sled until ride ends.
4. Must keep hands inside the sled at all times.
5. Must keep feet inside the sled at all times.
6. Must be 42" to ride the ice slide.
7. No eating or drinking while on slide.
8. No patron is allowed on slide if they have heart and/or back problems or are pregnant.

The Amphitheatre is not responsible for lost or stolen items.

UNDER NO CIRCUMSTANCES CAN CHILDREN UNDER THE AGE OF 12 YEARS OLD BE LEFT AT THE ST. AUGUSTINE AMPHITHEATRE WITHOUT PARENTAL SUPERVISION.

THE UNDERSIGNED HEREBY AGREES TO THE FOLLOWING:

1. I understand that ice skating and ice sliding is a **HAZARDOUS ACTIVITY**. I understand that ice skating and the use of skates involves risk of injury to any and all parts of my body. I understand that the ice slide and the use of the ice slide involve risk of injury to any and all parts of my body. I understand that there are numerous risks and dangers inherent in the sport of ice skating, including but not limited to: the unevenness of the surface and collisions with other rink users or objects. I understand that having a St. Augustine Amphitheatre employee present does not lessen the amount or severity of the risks of ice skating and ice sliding. I understand that the St. Augustine Amphitheatre is not responsible for my safety.
2. TO THE EXTENT PERMITTED BY THE LAW, THE UNDERSIGNED HEREBY RELEASES, WAIVES, DISCHARGES AND HOLDS HARMLESS ST. JOHNS COUNTY, THE CITY OF ST. AUGUSTINE, their directors, officers, employees, agents, and independent contractors from all liability to the undersigned and/or their personal representatives, assignees, heirs, and next of kin for any loss or damage and any claim or demands accruing or resulting from injury to the person or property or death of the above named Participant, whether or not caused by the negligence and/or property of St. Johns County, the City of St. Augustine, their directors, officers, employees, agents and independent contractors. (Note: a parent/guardian must also sign if undersigned has not reached his/her 18th birthday).
3. TO THE EXTENT PERMITTED BY THE LAW, THE UNDERSIGNED HEREBY ASSUMES FULL RESPONSIBILITY FOR AND RISK OF BODILY INJURY, DEATH OR PROPERTY DAMAGE, DUE TO THE NEGLIGENCE OF St. Johns County, the City of St. Augustine, their directors, officers, employees, agents, and independent contractors or otherwise the pertaining to the above-named Participant being in, upon or about the premises of St. Johns County or City of St. Augustine and/or while using the premises or facilities or equipment thereon.
4. THE UNDERSIGNED HEREBY PERMITS the photographs of themselves and/or the above named Participant by St. Johns County or City of St. Augustine during recreational activities performed at the Amphitheatre to be used at the County's reasonable discretion.
5. The St. Augustine Amphitheatre reserves the right to not allow a patron on the Ice Slide or Ice Skating Rink.
6. **THE UNDERSIGNED HAS READ AND VOLUNTARILY SIGNS THE RELEASE AND WAIVER OF LIABILITY AND INDEMNITY AGREEMENT FOR THE DURATION OF NOVEMBER 20, 2009 UNTIL JANUARY 3, 2010**, and further agrees that no oral representations, statements or inducement apart from the foregoing written agreement has been made.
7. I understand that under Florida Law, this Ice Rink, and Ice Slide Release Form will be considered a Public Record.
